Local involvement from an early stage

Current model

- First stages of the process: Consultation with authorities, e.g. the Municipality
- Public consultation happens later: Application for exploitation licence

Future model

- Public consultations earlier → From the very first application for exploration

- Ingerlattakkami aqquaagassat siullit: Pisortaqarfiusunik, soorlu kommunimik tusarniaanerit
- Tamanut ammasumik tusarniaaneq kingusinnerusukkut pisarpoq: Iluaquteqarnissamut akuersissut pillugu qinnuteqaat

Siunissami iluserisassaq

- Tamanut ammasumik tusarniaanerit siusinnerusukkut → Ujaasinissaq pillugu qinnuteqaammit sillerpaamit

What happens to the input?

- All consultation responses are collected at the One Door Authority
→ Mineral Licence and Safety Authority
- Consultation responses concerning environmental aspects
→ Environmental Agency for Mineral Ressource Activity
- Final decision at the political level
